In the reference 2nd read above, the Government of A.P have enhance the recognition period from (3) years to (8) years, duly amending the Andhra Pradesh Right of Children to Free and Compulsory Education Rules, 2010, issued in G.O.Ms.No.20, School Education (PE-Prog.I) Department, dated 03.03.2011 and inserting certain guidelines after clause (I) in Sub rule (4) of Rule 14 of the said G.O and the same was communicated by the Commissioner of School Education, AP, Amaravati in the reference 3rd read above.

In the reference 4th read above, the Government of AP have accorded permission to extend the recognition of the schools from 03 to 08 years those who have already taken recognition for a period of 03 years, to comply the orders dated 11.08.2023 of the Hon'ble High Court in W.P.No.18190 of 2023 and the same was communicated by the Commissioner of School Education, AP, Amaravati with a request to take necessary action accordingly in the reference 5th read above.

In the reference 6th cited, the Director, Coordination, O/o Commissioner of School Education, AP, Amaravati has issued instructions to all the RJDSEs and DEOs in the state that to complete the entire process of extending school recognition within the next two days for those institutions that have previously obtained recognition for a period of 03 years.

Previously, Grant of recognition has been accorded to Smt. Sethu Ramammal Vidya Mandir UP School, KSR Nagar, Jayanthipuram, Jaggayyapet for the classes LKG to VIII (EM) for 03 years from 2022-2023 to 2024-2025 in the reference 1st read above.

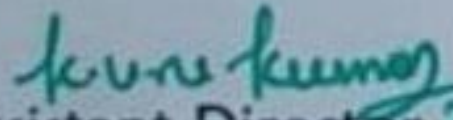
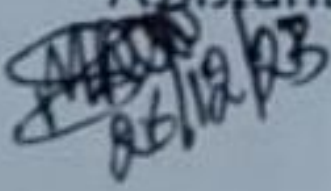
