1	The Board has decided to permit the grant of "Trust Name Change" on the basis of declaration submitted in Part-A and documents uploaded by the school, whereas, few documents are not at par as per Affiliation Bye-Laws and SARAS Manual i.e. Letter from State Government and Affidavit. However, the permission has been granted with subject to the following conditions: 1. School has submitted appendix-III instead of society change approval. As per circular no. 03/2021 dated 05.03.2021 serial no. 25 the appendix-III is deleted. Therefore, the school is required to submit approval stating that the indicated society modification is permitted and that the state government has no objections. 2. An affidavit has been submitted to the effect that old Trust name will not be used any more.
2	3. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018. 4. The approval is subject to final outcome of pending legal case/ litigation and any other issues arising out of transfer of school from one of Society/Trust/Company to another 5. The liability of the school, whatever before will be the liability of the school for all purpose, after change in name of Society/Trust/Company. 6. In case of land documents presently in the old Society/Trust/Company, the school will be required to submit revised land documents in favour of new name of school/society/trust/company within one month. 7.
